

**HealthCorps Luxury Raffle Sweepstakes
OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING.

Sponsor: HealthCorps Luxury Raffle Sweepstakes (“Sweepstakes”) is sponsored by HealthCorps, Inc. (“Sponsor”).

Sweepstakes Entry Period: The Sweepstakes begins on or about 12:00:01 a.m. Eastern Time (“ET”) on March 5, 2018 and ends at 11:59:59 p.m. ET on April 23, 2018 (“Sweepstakes Entry Period”). Sponsor’s computer is the official clock for the Sweepstakes. (“Sweepstakes Entry Period”). HealthCorps’ 12th Annual Garden Gala will be held at the Ziegfeld Ballroom (141 West 54th Street, New York, New York 10019, United States of America) on April 23, 2018 from 6:30 p.m. ET to 11:00 p.m. ET (the “Event”).

Eligibility: Sweepstakes is open only to legal residents of the 50 United States or the District of Columbia, 18 years of age or older, at time of entry. Employees of Sponsor, and its affiliates, parents, subsidiaries, divisions, and advertising and promotional agencies (“Sweepstakes Entities”), and their respective officers and directors and members of their immediate families (parents, spouse, domestic partner, siblings, children and step-children), are not eligible to participate. Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law.

How to Enter: There are three ways to enter the Sweepstakes:

Method #1: During the Sweepstakes Entry Period go to <https://www.gala.healthcorps.org/luxury-raffle>, click on the icon, and purchase a raffle ticket, and for every \$100 you spend you will receive one entry into the Sweepstakes (“Online Entry(ies)”).

Method #2: At the Event, you can purchase raffle tickets and for every \$100 you spend you will receive one entry into the Sweepstakes (“Event Entries”).

Method #3: To enter without purchasing a raffle ticket, print your name and complete postal address on a 3” x 5” index card or piece of paper, write the words “HealthCorps Luxury Raffle Sweepstakes” at the top, and mail it to HealthCorps, Inc., Attention: Sweepstakes, 33 Irving Place, 3rd Floor, New York, New York 10003. (“Mail-In Entries”). Mail-In Entries must be postmarked no later than 4/23/2018 and received by 4/30/2018. Only one Entry per envelope.

Online Entries, Event Entries, and Mail-In Entries are collectively referred to as “Entries(ies)” and the individual submitting an Entry is the “Entrant”. In the event of any dispute regarding any Entry, or element thereof, Sponsor reserves the right to disqualify that Entry or Entrant from the Sweepstakes. Receipt of Entries will not be acknowledged or returned. Use of automated Entry devices or programs is prohibited.

Selection of Winner: Three (3) potential winners will be selected in a random drawing from all eligible Entries received during the Sweepstakes Entry Period. The drawing will take place on or about May 1, 2018. The drawing will be conducted by Sponsor whose decision is final and binding in all matters relating to this Sweepstakes. The odds of winning are determined by the number of eligible Entries received.

Winners Notification. Potential winner will have to execute an affidavit of eligibility and release (“Release”) within fourteen (14) days of the date on the Release to be eligible to be awarded the prize. If a potential winner is a minor as determined by the laws of the jurisdiction in which s/he resides (“Minor”), the Minor’s parent or legal guardian will have to sign the Release on the Minor’s behalf. If a potential prize winner does not respond to the winner notification email (email will be sent three (3) times over a five (5) day period) or if said email is returned as undeliverable or does not return the executed Release within fourteen (14) days of the date on the Release; if an entrant is otherwise found to be ineligible or does not provide required information; or if the selected winner cannot accept or receive the prize for any reason, the potential prize winner will forfeit the prize and an alternate winner will be selected. The Sponsor reserves the right to modify the notification procedures in connection with the selection of an alternate winner, if any. Sponsor reserves the right to disqualify an Entry if Sponsor at any time receives a complaint alleging any violation of a third-party right pertaining to any element of such Entry. In the event of a dispute as to the identity of any Entrant of any Online Entry, the authorized account holder of the email address used to purchase the raffle ticket will be deemed to be the Entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winner may be required to show proof of being the authorized account holder for such Online Entry, or the Entrant of any Event Entry or Mail-In Entry.

Disputes; Governing Law. The parties waive all rights to trial in any action or proceeding instituted in connection with these Official Rules, including, without limitation, the Sweepstakes. The Sweepstakes and these Official Rules are governed by the laws of the State of New York, without respect to its conflict of laws principles. Any disputes, disagreements, or causes of action related to or involving the Sweepstakes or these Official Rules will be resolved in the state and federal courts located in the County of New York in the State of New York and Entrant agrees to submit to the jurisdiction of such courts and waive all jurisdictional, venue, and inconvenient forum objections thereto. Under no circumstance will Entrant be permitted to obtain awards for, and participant hereby waives all rights to claim, punitive, incidental, consequential, or any other damages, other than for out-of-pocket expenses. All causes of action arising out of or connected with this Sweepstakes, or prize awarded, shall be resolved individually, without resort to any form of class action; and any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees. The parties agree not to raise the defense of forum non conveniens.
